# **INCLUSIVE & EQUITABLE PROCTORING**

#### **PROCTORING OVERVIEW**

- Proctoring is the use of technology to ensure exam integrity when the students or candidates attend an exam virtually;
- Reduces workforce demand in online testing centers;
- Data analytics from proctoring tools assist in understanding learners' testing behaviors;
- Distance Learning Program students can appear for exams from wherever they reside.

# **PROCTORING MEASURES**

- Verification of the identity of the candidate;
- Observation of examination through webcams;
- Monitoring of the voice input and output of devices;
- Blocking of all website access from the exam device;
- Recording and monitoring of webcam feeds;
- Video archive to help resolve any disputes raised;
- Instructors can review the testing process.

# TYPES OF PROCTERING SOFTWARE PROGRAMS

#### LIVE PROCTORS

- A human proctor observes the testing sessions;
- Potential dishonesty is tagged in the recording;
- Students and proctors can talk to one another.

# AI PROCTORS

- A program records the testing session;
- Facial movement and eye tracking (Not Supported);

# UNIVERSITY ENDORSED PROCTORING SOFTWARE





- Both tools are supported by distance learning and work with Moodle;
- Students pay \$15 per 1-hour test;
- Both accept time extensions for accessibility consideration and must be requested by the instructor;
- Both use live proctors and record student web cameras and screens.

# **BEST PRACTICES AND RESOURCES**

#### INSTRUCTORS

Instructors issuing exams using proctoring software should engage in the following practices to ensure exam integrity:

- Be aware of the problems that can arise and be prepared to offer alternatives;
- Inform students ahead of time about associated costs with proctored exams;
- Contact Distance Learning if you have specific needs/concerns;
- Consider allowing some students to use a testing center (ex: Counseling and Testing);
- Take note of students requiring accommodations through the Office of Disability Services <u>https://disability.louisiana.edu/content/faculty-information/examination-procedures;</u>
- Utilize alternatives to proctoring when you can <u>https://distancelearning.louisiana.edu/teachremotely/proctoring</u> <u>alternatives</u>.

# EOUITY AND ACCESSIBILITY ISSUES THAT CAN ARISE IN PROCTORING

#### EQUITY ISSUES

#### **ACCESSIBILITY ISSUES**

#### **OFFICE OF DISABILITY SERVICES**

- Identity & Physical Characteristics
- Physical Impairments and Disabilities
- Can only communicate with the instructor about the accommodation

- Socio-economic & Financial
- Learning Disabilities & Anxiety

#### **EQUITY ISSUES: IDENTITY & PHYSICAL CHARACTERISTICS**

Problems with identification during the authentication process:

- Darker-skinned students may have trouble identifying and may be asked to shine a light on their faces:
- Transgender students may not physically appear as they do on their official identification (especially transitioning students).

# EQUITY ISSUES: SOCIO-ECONOMIC

- Space and enclosure requirements that may be challenging for some students to adhere to:
  - Lack of the required fully enclosed space;
  - Noise Issues; earplugs or ear devices are not allowed:
- Cost-related issues:
  - The burden of cost to take a proctored exam is on the student;
  - Computer upgrades to run certain proctoring software programs can be expensive.

# ACCESSIBILITY ISSUES

#### PHYSICAL IMPAIRMENTS AND DISABILITIES

- Lockdown Browsers Students with visual impairments are often locked out of assistive technology like screen readers.
- Fidgeting Students will often get flagged for cheating if they "fidget" while taking an exam.

#### LEARNING DISABILITIES & ANXIETY

- Reading questions out loud is prohibited by many proctoring companies, however, some students with learning disabilities benefit from reading aloud;
- **Exam Access Difficulties** Students with anxiety may become more anxious if they have trouble accessing the exam;
- Countdown Clocks Some students with anxiety are made more anxious by countdown clocks;
- **Breaks** Students are allowed intermittent breaks at testing centers, but breaks are not allowed during proctored exams;
- Settings that block students from revisiting questions Students with Learning Disabilities may need to skip over and revisit questions.
